ONE PLUS ONE

- **aka:** One-Year Option
- **Status:** Work is currently focused on establishing a one year option credit articulation system for adults graduating from Ohio Technical Centers (OTCs) who complete 900 hour programs of study and obtain an industry-recognized credential. There will be transferability of 600 to 899 hours of proportional credit. Recommendations are due by June 30, 2014
- **Legislative Requirement?:** Yes
